
I am so blessed to have had several telephone conversations with David and his wife.

A praying teacher isn't letting her school get away with viewpoint discrimination.

Keisha Russell, senior counsel at First Liberty Institute, says Taryn Israelson wanted to pray for and with the faculty and staff at J.R. Smith Elementary School in Heber City, Utah.

Russell, Keisha (First Liberty



"She felt led to have a prayer chain, so on a piece

of paper, she posted something that just said, 'Need prayer? Text me to be added to the prayer chain,'" Russell relays.

She asked three of her non-religious coworkers to make sure that wording was not offensive.

A First Liberty press release

approved Israelson's flyer two years ago, but this year, the school principal told her to take it down.

"Even though

"Even though other people are allowed to post things in the break room, she's not allowed to post that just because it's religious," the

attorney summarizes.

That, she asserts, is a violation of the Constitution and federal law.

"We wrote a letter on behalf Taryn Israelson; First Liberty and [the law firm] Mayer Brown got together and wrote a letter on her behalf, and we're hoping the school district will do the right thing," says Russell.

The Wasatch County School District has until May 14 to respond. If Israelson is not allowed to continue posting her prayer chain, then litigation will be considered.



Flag Controversy in Boise Raises Questions About Law, Governance, and Accountability

A growing legal and political controversy is unfolding in Boise, Idaho, after Mayor Lauren McLean chose to fly the Lgbtq+ Pride Flag at City Hall, despite the recent passage of House Bill 96 (HB 96), which restricts the display of unauthorized flags on government property.

Signed into law by Governor Brad Little on April 3, 2025, HB 96 limits flags on public buildings to a specific list, including the American flag, Idaho State flag, military and POW/MIA flags, tribal flags, and official flag of government entities. The Pride flag is not on that list. Boise City Council, in an effort to skirt the law, in a 5-1 vote, passed a resolution on May 6 designating the Lgbtq+ flag as an "official city flag." We believe this maneuver is a political workaround that violates the spirit—if not the technical letter—of the law.

HB 96 was designed to ensure neutrality in government spaces by restricting political, ideological, or cause-related flag displays. The legislation passed through Idaho's standard legislative



process and received broad support from lawmakers and constituents who viewed it as a measure to protect public spaces from politicization. The legislature has a reasonable expectation that government entities and other elected officials that have sworn an oath to uphold the constitution will follow the law. It would be impossible to put a penalty into every directive given to government.


Attorney General Raúl Labrador weighed in, by issuing a letter, confirming that Mayor McLean's initial decision to fly the Pride flag violated the law.

Undermining the Rule of Law

The mayor's actions have sparked concern across the state. This sends a dangerous message—that government officials can pick and choose which laws to follow. While HB 96 does not impose criminal penalties, the violation is still a civil offense and sets a troubling precedent for selective law enforcement. If the city government can pick and choose what laws it wants to follow, why can't city residents?

Under Idaho law, state legislation overrides local ordinances. While cities may pass resolutions, they cannot override or subvert the intent of state law.

Teacher Fights Back After Principal Breaks Prayer Chain in Faculty Lounge

A first grade teacher in Heber City, Utah, Taryn Israelson, is fighting a battle over the posting of a prayer chain letter in the faculty lounge.

She had permission from the school's Human Resources department, but the school principal told her it must be removed.

Keisha Russell of First Liberty, who is representing Israelson, says Human Resources was right and the principal of J.R. Smith Elementary is guilty of viewpoint discrimination by asking Israelson to remove the prayer chain.

"If the school district is going to allow teachers to have private speech in a certain area that includes their like personal desk space they can't then say, Taryn, as a teacher can't post anything religious."



Israelson, after receiving approval from the Human Resources manager, began a voluntary

prayer chain in which individuals could opt-in to receive prayer and to pray for others.

She posted a sign in the school faculty lounge two years ago to invite faculty members to participate.

The faculty lounge provides members a place to gather and socialize during breaks and post personal signs on the refrigerators advertising community plays, announcing weddings and baby showers, sharing motivational phrases, and engaging in other forms of personal expression.

Russell points out that while this case is in Heber City, Utah, this is a problem that is widespread in schools nationwide.

"So we're seeing this kind of hostility all across the country with a lot of school districts that just

don't understand the law, and how it applies in the school context."

She's hoping with the demand letter from First Liberty the school will relent and let Israelson have her prayer chain. But if not, they are willing to resort to litigation.

Problematic 'Kelly Loving Act' Also Affects the Press

Closely reading a controversial bill in Colorado, an attorney says parents aren't the only ones who could be guilty of a crime for calling a child by his or her name.


In addition to endangering the custody rights of a parent who "misgenders" or "deadnames" his or her own child, the so-called "Kelly Loving Act" says that "threatening to publish material related to an individual's gender-affirming health-care services" is a type of "coercive control."

According to attorney Erin Friday, that means HB25-1312 goes further than most people realize.

"This bill affects the press and its Freedom of the Press," she recently told Fox News. "It will require the press to use the chosen name of a child."

That is unconstitutional.

"It's a massive First Amendment violation," Friday asserted. "We need to fight this in the courts, in the public domain, and, of course, standing up at these legislative hearings."

The measure also requires dress-coded public schools to allow children of either sex to choose between following the boys or girls dress code without their parent's consent or guidance.

The attorney noted the importance of remembering exactly what a transgender child is: a child who

has acute distress about their natural body.

This bill, she said, would add to that distress by telling them their parents "who look at them and love them as their natural selves are bigots and horrible people and hateful people and don't deserve to be their parent."

Parents and their Republican advocates take issue with the measure's disregard for parental rights, but the Colorado House of Representatives approved the bill earlier this month. It is now pending a vote in the Democratic-majority Senate before proceeding to Governor Jared Polis' (D) desk.


Advocate Urges Consumers to Understand Rights as Genetic Research Company Folds by Chris Woodward Used by permission, American Family News, afn.net March 27, 2025



The genetic testing company known as 23andMe is filing for bankruptcy and looking for a buyer. At least one attorney general is advising residents of his state to take action.

Attorney General Austin Knudsen (R-Montana) is encouraging Montanans to protect their genetic data and reminding them of their right to delete genetic data from DNA testing companies.

"Montana law requires companies, like 23 and Me, to obtain consumers' express consent for the sale, transfer or use of genetic data for research purposes," says the Montana Department of Justice in a press release. "The law also requires companies to allow for the deletion of a consumer's genetic data and destruction of a consumer's biological sample. Montanans may revoke any previously granted consent."





Should other states do the same? Twila Brase, RN and president/co-founder of Citizens' Council for Health Freedom says that depends on what if any options they have for protecting their data.

"People who have donated or given their DNA samples to 23andMe should look at the fine print in the document in the contract that they signed and see if they have any right to do anything to get that information and those specimens back or require that they be destroyed," says Brase.

Citizens' Council for Health Freedom warned about genetic testing companies years ago when

they were new. For starters, Brase says some of the concerns involve customers not getting accurate information.

"The second thing was what's going to happen to the DNA, and when we looked into the fine print

of the contracts, there was this section about third party access, and so I think people who sent their information in don't actually know what third parties may have been given access to their DNA," says Brase.

Sharing your DNA

This particular company wasn't looking at Montana only.

"Another thing to know is that 23andMe was part of a coalition or a genetic alliance going from state to state trying to get access to the DNA and being able to share it at will without having to worry about any kind of informed consent constraints."

Citizens' Council for Health Freedom played a role in helping Montana's law passed.

The Power of **Forgiveness**

Jesus often spoke of the need for forgiveness. It is fundamental in the Christian life. We are very thankful that He forgave us when we first came to the cross and accepted Him as our Savior. That is not the end but the beginning of a life of forgiveness as we walk with Him. He gave us a pattern for prayer early in



His ministry, often called the Lord's Prayer in Mt 6:9-

This, then, is how you should pray: "Our Father in heaven, hallowed be your name, your kingdom come, your will be done, on earth as it is in heaven. Give us today our daily bread. And forgive us our debts, as we also have forgiven our debtors. And lead us not into temptation, but deliver us from the evil one.'

This pattern for prayer includes forgiving others as we are also forgiven. That is not as easy as it sounds. Accepting His forgiveness maybe not so hard as forgiving others or even ourselves. That is sometimes a struggle.

Some years ago, I came across a Christian psychology book from the 1950's. It was quite interesting especially concerning the concept of "frozen rage" and how it affected our body and mind. The concept was quite ahead of its time. Many of the issues of unforgiveness were not really studied so well back then. Since then, many academic studies have taken on this issue publishing the results in popular press as well as in scientific journals. The effect of maintaining the anger toward someone who has wronged us has profound effects on our lives. Letting go, and forgiving has a strong positive physical effect as well as providing spiritual benefits.

So, what does unforgiveness do to us? We may

Another Win for Students in Idaho

The Gem State has a new law that protects free speech on college campuses.

In a state that has seen lawsuits against universities amid a larger trend of restricting speech based on viewpoint, Governor Brad Little (R) has signed free speech protections

Zack Pruitt, senior counsel Alliance Defending Freedom, says the Protecting Campus Speech Higher in

Education Act (HB 240) keeps colleges and universities from

restricting certain viewpoints by clarifying definitions in state code with respect to harassment, students, and student groups.

"All of these definitions are designed just to make



sure that the university officials are viewing these subjects and these topics in the way that the Supreme Court has defined them," Pruitt tells AFN.

The bill also bans the use of so-called "free speech zones"

"Free speech zones are something that we've seen schools use across the country to kind of take certain points of view and restrict them to far areas of campus where there's not as much foot traffic," the attorney explains.

That limits a speaker's ability to reach his or her intended audience, and it is something that Pruitt says has been "repeatedly ruled unconstitutional."

HB 240 also prohibits security fees from being applied in a viewpoint-based manner, meaning administrators cannot decide that a conservative speaker, for example, will have high security fees and that a liberal speaker will have minimal to no security fees.

Lastly, Pruitt says the new law simply requires disclosure to students, faculty, and administrators to ensure everyone knows their rights and the state's policies under the new law, which allows a student or student group whose

rights have been violated to bring their case to a state court.

This comes on the heels of Gov. Little signing the Parental Choice Tax Credit bill (HB 93) into law in February – legislation that made school choice programs available for the first time in the state's history.

Father Blasts School Board as Gender Bill Makes Its Way Through Colorado State Legislature

A Colorado father vented his anger to his school board, claiming the school cost him custody of his own daughter.

House Bill 1312 is making its way through Colorado's legislature. It would classify parents as abusive if they don't affirm their child's so-called 'gender identity.'

CBN and others report that if it passes, it could result in children being removed from their homes.

One father, Dustin Gonzalez, said it is already happening.



He lit into the Jefferson County Public Schools Board of Education earlier in the month, saying his twelve-year old daughter was socially transitioned at school. The child was led to a different

sexual identity without his knowledge or permission.

"My daughter changed her identity, not after years of discussion or family dialogue, not of her joint input from both of her parents, no, this happened quickly, secretly, encouraged by a school-appointed therapist in a system that never thought to include me. And the school didn't inform me. They didn't include me. They didn't even ask me. They replaced me."

He said that by the time he found out, he was already labeled the problem.

"My objections weren't treated as concerns. They were treated as opposition. My voice was dismissed as hateful, my presence undermined. The therapist, the school, and eventually the court-appointed investigator all decided that because I would(n't) affirm something, I didn't deserve to parent my daughter equally anymore."

HB 1312 is also known as the "Kelly Loving Act." It would make "misgendering" and "deadnaming" be considered discrimination.

The bill's next stop is the Colorado Senate Judiciary Committee. If it passes, it will move to the floor for a vote before the entire senate.

"Now, I'm at risk of losing parenting time, of being erased from my daughter's life-- not because I failed as a father, but because I dared to ask questions, and it started in your schools. Your systems made it possible, and your silence made it permanent. You gave my ex all the tools she needed to take our daughter from me, tools that she couldn't have forged on her own. You gave her the therapist, you gave her ideological support, and you never once thought 'shouldn't the father be involved, too?""

The U.S. Supreme Court has decided to take up a challenge to Colorado's talk therapy ban.

Kaley Chiles is a Christian counselor who wants to help people who voluntarily come to her with unwanted same-sex attractions or gender identity issues. Colorado does not allow this to occur and refers it to as "conversion therapy."


Barnett thinks the Supreme Court, which has been clear that the First Amendment applies to professionals, has indicated it wants to "correct that error."

As more than 20 states and over 100 smaller jurisdictions have enacted similar laws, this case could free up counselors across the country, allowing them to freely speak to their clients and allowing clients to freely pursue their counseling goals.

So Barnett says it is "critical" for counselors, families, and professionals across the country.

"If Colorado can censor what a counselor says, then any state can censor anything a professional does by calling it conduct, which is what Colorado has done in this case," he explains. "So, this has implications that ripple far beyond Colorado and even the counseling room itself."

The case will not be argued until the next term, which does not begin until October. A decision would come by June 2026.

Integrated into the class are weekly review questions, group discussion, corporate worship in multiple languages, prayer, personal responses and an integrative project of devising a strategy for reaching an unreached people group.

As the local team reflects on the first Perspectives class in Idaho Falls, they see God's hand in bringing together everything it took to execute the course and for all that God did and will do in the lives of the students. The process to bring Perspectives back to South East Idaho is in the works with a Perspectives Alumni Gathering, where 32 Perspectives

Alumni were invited to discuss and seek the Lord for direction.

According to multiple reports, Trump's meeting with Saudi Crown Prince Mohammed bin Salman will also include Palestinian Authority President Mahmoud Abbas and Syrian President Ahmed al-Sharaa. These are not peace brokers — they are longtime allies of jihadist ideology, whose goals align more with Iran than with any genuine path to coexistence.

At the same time, Iran's foreign minister Abbas Araqchi stated in Doha that Tehran will not back down from its "nuclear rights." They have made uranium enrichment non-negotiable — even as new nuclear talks are being quietly prepared.

Trump is traveling with a full political and economic team: Middle East Envoy Steve Witkoff, Secretary of State Marco Rubio, Treasury Secretary Scott Bessent, and Commerce Secretary Howard Lutnick. These are not ceremonial delegates, this is a coordinated effort — not just to manage headlines, but to deliver a historic deal.

On Sunday night, Steve Witkoff, Trump's Special Envoy to the Middle East, told hostage families that the U.S. wants to return the hostages, but "Israel is not ready to end the war." He accused Israel of prolonging the conflict and called for an agreement to be reached immediately, regardless of Israel's military strategy.

For months, I have warned that Steve Witkoff's plan would backfire, that his admiration for Qatar, Oman, and even Putin would lead to disaster. And now, instead of taking responsibility for his misguided strategy, he is blaming Israel. His frustration is not with Hamas — it is with Jerusalem. These are not the actions of a true ally. This is the exposure of a dangerous agenda.

There is a price for this kind of gesture. There is always a price. And the question must be asked: are we on the edge of a deal that might be the last?

The White House can deny this, but where there is smoke, there is fire. And the danger here is not just political — it is real.

Abbas believes in jihad. Syria's regime has overseen mass slaughter. Iran is openly committed to Israel's destruction. These are the voices in the room. And Israel is not among them.

This administration may not say it supports a two-state solution. But if its architects are willing to trade hostages, oil, and recognition for quiet, the outcome may be the same. And it may come wrapped in applause.

How can the United States sit at the table with the president of Syria — a man whose regime has slaughtered thousands, including dissidents, Christians, and innocent families — and still claim moral ground? How can any deal be made with leaders whose hands are stained by the very ideology we once vowed to fight?

You don't negotiate with extreme jihad. You don't dignify the voices that persecute believers and

massacre their own people.

In 2001, after 9/11, Pat Robertson stood up and called things as they were. He spoke against radical Islam. He named the threat. He told the truth. And he wasn't afraid to say it publicly. Today? Silence. Fear. A culture afraid to offend.

The Church must stay awake. The leaders must stay clear. And America must ask itself: what is the cost of this table?

Let us pray that President Trump sees the fire.

Hours after Edan Alexander's release was confirmed, President Trump posted: "I am happy to announce that Edan Alexander, an American citizen who has been held hostage since October 2023, is coming home to his family. I am grateful to all those involved in making this monumental news happen. This was a step taken in good faith towards the United States and the efforts of the mediators — Qatar and Egypt — to put an end to this very brutal war and return ALL living hostages and remains to their loved ones. ..."

But in doing so, he is putting the entire world—the UN, the ICC, and public opinion—against Israel. This was not about celebrating a rescue. It was about executing the will of Qatar, Hamas, and Egypt to stop Israel's war before it could finish. With Witkoff's comments and Trump's public posture, this administration has done more to undermine Israel in one week than some enemies have achieved in years.

This is not a celebration. It's a political exchange designed to pressure, isolate, and disgrace Israel — just when she was preparing to finish the fight.

It is fed by bringing it up and maybe even exaggerating it rather than working on letting it go. Maybe the thought of revenge drives your life and gives you purpose, not really a good purpose.

The anger and resentment are like a ball of negative energy kept frozen in the brain and it keeps leaking out in some form or other. We may express fits of rage or anger at situations that do not deserve such a reaction. We may develop depression, anxiety panic attacks and other psychiatric symptoms. Though not the only reason we develop those symptoms but this is not an uncommon and very treatable cause.

acid in the stomach can increase with stress to the point that an ulcer can develop. There are medical causes for such but we can create this with our psychological and spiritual issues as well. Recurrent headaches, chronic back and neck pain can come from the internalized rage. The body may develop inflammation as though the rage is expressing itself by attacking the body. Our immune system may respond with less ability to fight off invading viruses and maybe even errant cancer cells the body would ordinarily dispose of.

We do feel we have the right to be angry about injustices against us and certainly on a human level we do! The world seems rather unfair and really it is. It is a broken world full of sin and darkness. We then truly accept the forgiveness from God given to

They were able to grow into fairly welladjusted adults.

> Some rage and anger can come from not forgiving oneself. This is rather hard to do as well. This is particularly hard with some addictions. As one suppresses the anger and shame toward oneself it can lead to more self-defeating behaviors and worse problems with the addiction. We somehow think that we know better than God what can be forgiven. This really comes down to pride. How do we forgive ourselves? It is a process for most. First, we humble ourselves under the mighty hand of God James 4. We admit our powerlessness to overcome the addiction/ sin that has not allowed us to forgive ourselves. We

are full of sin and darkness until we meet Jesus. Even us from Jesus' sacrifice. If we do not know Him, it is time to get acquainted! We can then humbly and gradually accept the healing that comes. 

House Speaker Mike Moyle has stated that taxpayer dollars shouldn't subsidize open defiance of state law. There has been talk amongst legislators about withholding state tax revenue from noncompliant cities and discussions on how to hold elected officials that break the law accountable.

For many Idahoans, this controversy is about more than just a flag. It's about accountability, transparency, and the integrity of public office. When elected officials act unilaterally or defy state law, it chips away at public trust and emboldens further disregard for law and government processes.

The political consequences could be swift. Recall efforts, public protests, and heightened voter engagement in Boise's upcoming municipal elections are already underway. On the fiscal side, city taxpayers may bear the cost if state funds are withheld as a consequence of noncompliance.

If you are concerned about this issue we encourage you to:

 Contact your state legislators to support enforceable penalties for elected officials that violate the law.

states, in the U.S. Constitution.

As far as President Trump, Ivory said Utah's legislators are urging the White House to reinstate a

resolution, first introduced by Ronald Reagan, that defines and defends federalism.

Ivory is likely referring to a 1987 executive order, signed by Reagan, which AFN found online at the Ronald Reagan Presidential Library. "Federalism," the executive order states, "is rooted in the knowledge that our political liberties are best assured by limiting the size and scope of the national government."

The White House is considering Utah's request to affirm federalism, Ivory said, but he told the AFR program it is up to the people to understand a state's authority under the 10th Amendment and the federal government's limited jurisdiction.

"It all starts right with us," he said.


